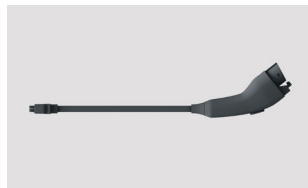


Lucid RangeXchange™ User-Guide

RangeXchange Adapter Tail



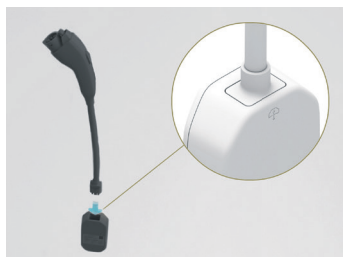
14-50 Adapter Tail

Insert RangeXchange Tail

Line up the RangeXchange icons on the adapter tail and the Lucid Mobile Charger,* then insert the adapter tail fully so that it is flush.

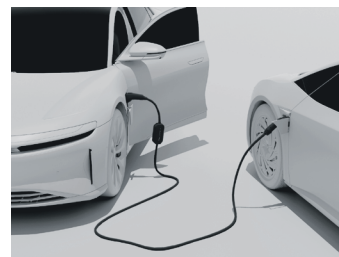

Plug into your Lucid

Plug the RangeXchange adapter into the Lucid vehicle that will be providing its energy. The charge port light will pulse blue.

Plug into the receiving vehicle

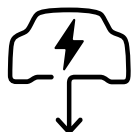
Plug the other end of the cable into the receiving vehicle. Use of an appropriate adapter is required for RangeXchange to be compatible with the North America Charging Standard.

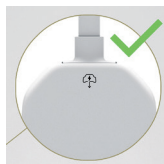


Start sharing

Tap the "START SHARING" button on the Pilot Panel of the donor vehicle to begin the RangeXchange session.

*Your Lucid Mobile Charger must have the RangeXchange icon to ensure compatibility. If no icon is present on your charging cable, it is not functional with the RangeXchange adapter tail.

While energy is being shared, the Lucid logo on the Lucid Mobile Charger will pulse white. The charge port light will pulse blue and indicate the current battery level of your Lucid.

Lucid Genuine Spare Parts and Accessories Limited Warranty

Who May Use this Limited Warranty:

This Limited Warranty is provided to the original purchaser and subsequent owner(s) of the relevant genuine spare part or accessory during the Warranty Period.

What is the Warranty Period:

Two years from the date of purchase (there is no mileage limitation on this coverage) and unlimited miles, except that Lucid genuine spare parts and accessories when installed on a new vehicle prior to delivery to a customer (and included on the new vehicle invoice) are covered for the balance of the Lucid New Vehicle Limited Warranty applicable to that part or accessory. Customer must provide proof of date of purchase of the part or accessory.

What Does this Limited Warranty Cover:

Manufacturer Lucid USA, Inc. will cover the repair or replacement of manufacturing or material defects on all Lucid genuine spare parts or accessories for the Warranty Period as defined above. If the part or accessory was installed by a Lucid service technician, labor costs for replacement are also covered.

What the Limited Warranty Does Not Cover:

This Limited Warranty does not cover damage caused by failure to follow any accompanying instructions for installation, use, care, or maintenance. Damage caused by normal wear and tear, outside influence, environmental factors, accident, abuse, neglect, alteration, and application of chemicals including improper cleaning products is also not covered under this Limited Warranty.

This Limited Warranty does not cover parts and accessories that were not originally purchased from Lucid, were installed on an improperly used or maintained vehicle, or were known to be defective prior to being installed on the vehicle.

What is the Remedy: The exclusive remedy under this Limited Warranty is limited to repair or replacement.
